Kashmir Civitas is a civil society and strategic advocacy organization committed to the socio-political, educational, economic and moral empowerment of Kashmiris. Our organization campaigns for the fundamental right of self-determination for the people of the disputed territory of Jammu and Kashmir. This is premised on their inalienable rights and includes a total of 18 United Nations (UN) Resolutions on Kashmir. More specifically, Security Council Resolutions 39 adopted on January 20, 1948 and UN Security Council resolution 47, adopted on April 21, 1948.

Our organization champions the democratic principles of freedom, equality and the inherent dignity of all human beings, irrespective of race, religion, gender or creed. It aims to raise awareness - by academia, social media, print, film etc... to inform public opinion about the political repression, victimization, and denial of basic human rights of Kashmiris. It will support orphans, education of needy individuals and hold conferences, seminars/workshops on peace-building and conflict resolution initiatives.
